## SEASON REMINDERS

**Dress Code Changes:** Jeans/Denim will not be permitted for use on any of the golf facilities during the golf season.

Please make sure that your attire remains “golf appropriate.”

**Group Size:** Groups may not exceed (4) players during the golf season

**Guest Restrictions:** A guest may not play more than (6) total rounds per year. The golf staff will be keeping a record of all guest play and hopes that everyone will be cooperative in our efforts to enforce this rule.

**Tee Times/Range Hours:** Tee times will begin at 9:00 am on weekdays and 8:30 am on the weekends beginning April 3rd. The driving range will be open at 8:30 am Tuesday – Fridays and close at 6:30 pm. On Saturdays the range will open at 8:00 am and close at 6:30 pm. Sundays the range will open at 8:00 am and close at 5:00 pm. Please check the newsletter/website calendar monthly to keep up with the time changes for each month.

This website will serve as the portal to your online account as well as current events at the club. As you have noticed, we implemented new point of sale and club management software. We are still working through a few issues with the system which is not unusual for a changeover of this magnitude. Please be patient as staff continues their best efforts to integrate this new system.

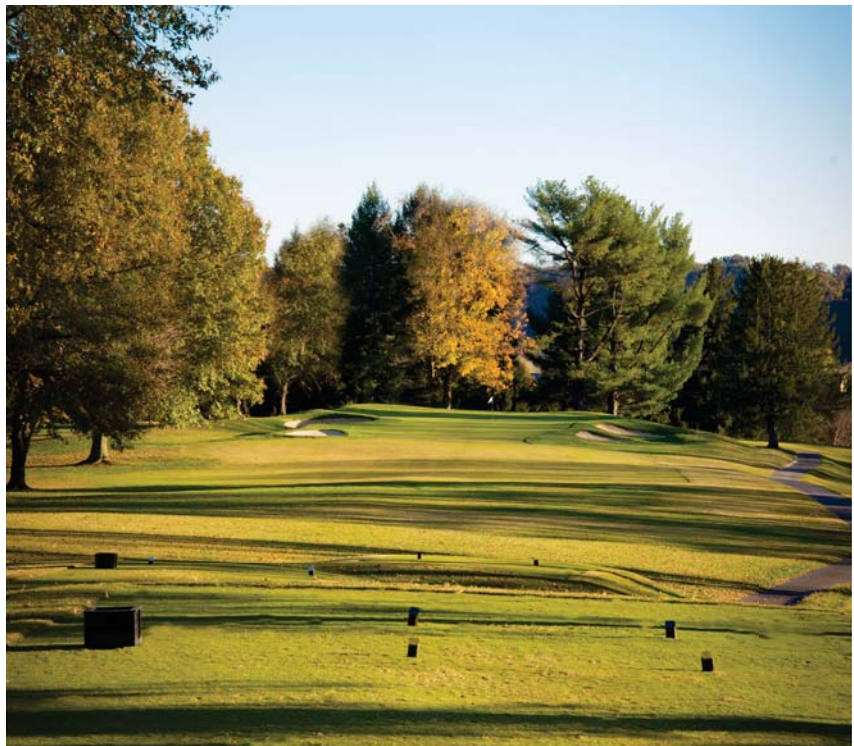
There are some very important aspects of the new system of which you should be aware: Please try to pay your bill by the 26th day of each month, if possible. The new software will generate your invoice as of midnight on the last day of the month and the staff need sufficient time to log your payment so you do not incur a late fee. The new system is web based and allows you to book tee times online and view your account history in

real time. You should check your account for accuracy as you incur charges. Your account history will convert to an invoice as of midnight the last day of the month. You can view your invoices online and make your payment to the office based upon the online invoice. You will also be emailed your invoices. If you are willing to forego the receipt of a mailed paper invoice, please contact the office staff and let them know. Electronic invoicing will save us significant overhead expense. You will continue to receive a paper invoice unless you notify us otherwise.

You may have received an email notification from the office which provides specific instructions about viewing and managing your online account. These instructions are also available in paper form in the office. At this time, you cannot pay your invoice online, but that option will be available in the future.

Thank you for being a member of Sleepy Hollow Golf Club and I am looking forward to continuing our effort at making Sleepy Hollow the best golf club in the tri-state area.
